I. Introduction

The current assignment provides temporary introductions on (1) an summary of problems of rights of persons with disabilities at the worldwide level (2) issues a couple of special instrument for the rights of persons with disabilities and (3) choices for future action for promoting rights of persons with disabilities.

II. Summary of the rights of persons with disabilities at the international level

A. elementary rights of persons with disabilities

The UN Charter affirms the essentialness of “a universal respect for, and observance of, human rights and elementary freedoms for all while not distinction...”

The rights of people with disabilities are grounded during a human rights framework supported the UN Charter, the Universal Declaration of Human Rights, international covenants on human rights and connected human rights instruments.

Persons with disabilities are entitled to exercise their civil, political, social, economic and cultural rights on an equal basis with others underneath all the international treaties. the complete participation of persons with disabilities advantages society as their individual contributions enrich all spheres of life and this is often an integral a part of individual's and society's well-being and progress for a society for all - with or while not disabilities.

The rights of people with disabilities are addressed additional usually throughout the event of the international human rights law. The principle of the proper to equality, addressed throughout the normative standards began by the international human rights instruments is that the foundation of the rights of people with disabilities. so as that the rights of persons with disabilities could also be any realized, modern jurisprudence has more and more recognized the requirement for all states to include human rights standards into their national legislation. though the means that chosen to market full realization of economic, social and cultural rights of persons with disabilities might disagree among countries, there's no country exempt from the requirement for improved policies and laws for people with disabilities.

B. International Norms and Standards regarding the rights of persons with disabilities

The international human rights instruments address the rights of people with disabilities each usually and specifically. There are a variety of specific international human rights instruments, which might contribute to the promotion of the rights of persons with disabilities. Samples of such instruments are: the Convention on the Elimination of All styles of Discrimination against Women; the Convention against Torture and

alternative Cruel, Inhumane, or Degrading Treatment or punishment and also the Convention on the Rights of the kid.

Research has indicated that the results of handicap are significantly serious for girls. Ladies with disabilities are discriminated against on 2 grounds: gender and incapacity, and infrequently they need less access to essential services like health care, education and rehabilitation. General Recommendation eighteen by the Committee on the Elimination of All styles of Discrimination against ladies specifically deals with the problem of ladies with disabilities. The elective protocol to the Convention on the Elimination of All styles of Discrimination against ladies that was adopted by the overall Assembly in 1999 can also give a vital venue to specifically address the problems regarding ladies with disabilities.

Disability typically arises from war and bestial treatment. The Convention against Torture and alternative Cruel, Inhumane, or Degrading Treatment or punishment could also be utilized to confirm that applicable state action be taken for people who became disabled as a result of bestial treatment also on promote interference.

In addition to the overall international human rights instruments, disability-specific instruments regarding the rights of persons with disabilities are adopted at the international level. Not like the said international legal instruments, these instruments are declarations, resolutions and normative tips adopted by the UN General Assembly that aren't de jure binding. These embody the Declaration on the Rights of people Persons, the Declaration on the Rights of Disabled Persons, the globe Program of Action regarding Disabled Persons, the capital of Estonia tips for Action on Human Resources Development within the Field of incapacity, the Principles for the Protection of Persons with mental disease and also the normal Rules on the deed of Opportunities for Persons with Disabilities.

C. Historical summary of Policy Development at the International Level

In the Nineteen Forties and Fifties, the UN centered on promoting the rights of persons with physical disabilities through a spread of welfare approaches. within the Nineteen Sixties, initiatives at intervals the incapacity community, as well as the adoption of the International Covenant on Civil and Political Rights and therefore the International Covenant on Economic, Social and Cultural Rights, resulted in a very elementary valuation of the rights of people with disabilities at intervals incapacity policies.

In the Nineteen Seventies, the growing international concern with human rights for persons with disabilities was specifically self-addressed by the final Assembly within the Declaration on the Rights of people Persons, the Declaration on the Rights of Disabled Persons and by proclaiming 1981 because the International Year for Disabled Persons.

The human rights of persons with disabilities became a crucial a part of the international policy agenda within the Eighties. The planet Program of Action regarding Disabled

Persons was adopted by the final Assembly at its ordinal session in 1982. the planet Program of Action may be a comprehensive international strategy that utilizes “equalization of opportunities” as its tenet for the action of full participation of persons with disabilities, on the premise of equality, all told aspects of social and economic life and development. The planet Program remodeled the incapacity issue from a "social welfare" issue to it of integration the human rights of persons with disabilities all told aspects of development processes.

In the Nineties, as a big outcome of the world organization Decade of Disabled Persons (1983-1992) the quality Rules on the leveling of Opportunities for Persons with Disabilities were adopted by the ordinal session of the final Assembly in 1993. the quality Rules ar a world instrument with a personality's rights perspective for disability-sensitive policy style and analysis furthermore as for technical and economic cooperation.

D. Recent developments regarding the broad human rights framework to market the rights of persons with disabilities

The UN conducted a comprehensive comparative study of world incapacity policies and programs in 1997, issued as a Report of the Secretary-General, “Review and appraisal of implementation of the planet Program of Action regarding Disabled Persons.” This study indicated that a broad human rights framework should be any developed and established for incapacity policies and programs to market social, economic and cultural rights furthermore because the civil and political rights of persons with disabilities. Major international conferences and summits that were organized throughout the primary half the Nineties on a spread of development agendas adopted action plans and programs during which participation, inclusion and improved well-being of persons with disabilities were accorded a special stress. The study any indicated that so as for the rights of persons with disabilities to be recognized, a broad human rights framework, drawing upon the appreciable body of international norms and standards within the social, economic, civil, cultural and political fields is required. This framework doesn't merely profit persons with disabilities however conjointly contributes to the advancement of the rights of all persons in society.

Most recently, the fifty-sixth session of the Commission on Human Rights adopted resolution 2000/51 of twenty five Apr 2000, entitled “Human Rights of Persons with Disabilities.” The resolution invitations written agreement bodies and their Special Rapporteurs to incorporate the rights of persons with disabilities within the watching of the implementation of the relevant human rights instruments. The resolution conjointly urges Governments to incorporate the question of human rights of persons with disabilities in their reportage needs beneath the prevailing human rights treaties and needs cooperation with the Special recorder on incapacity of the Commission for Social Development and therefore the diplomatist for Human Rights to look at doable

measures to strengthen the protection and watching of the human rights of persons with disabilities.

III. Problems regarding a special instrument on the rights of persons with disabilities

A. Historical summary

1980s:

A number of initiatives are taken to handle the problem of elaborating a brand-new disability-specific international instrument. The primary initiative emerged within the international Meeting of specialists to Review the Implementation of the planet Program of Action regarding Disabled Persons at the Mid-point of the international organization Decade of Disabled Persons. The govt. of Italy, in relevancy the professional conferences command in national capital and Ljubljana, raised the problem of the likelihood of a world convention in 1987 at the ordinal session of the overall Assembly. At the ordinal session of the Assembly, in 1989, the govt. of Kingdom of Sweden projected the elaboration of a world instrument on the rights of persons with disabilities. However, an accord wasn't reached on a de jure binding instrument; several representatives expressed the read that existing human rights instruments would appear to ensure persons with disabilities an equivalent rights as persons while not disabilities.

1990s:

Agreement was ultimately reached on elaboration of a non-binding instrument on the rights of persons with disabilities. In 1990, the Economic and Social Council licensed the Commission on Social Development to contemplate institution of a social unit, funded by voluntary contributions, to elaborate the quality Rules on the feat of Opportunities for Persons with Disabilities. Following a series of technical conferences and thought by the Commission for Social Development, the quality Rules were nemine contradicted adopted by the overall Assembly at its 48th session in 1993.

Mr. Bengt Lindqvist was appointed by the Secretary-General as Special recorder on incapacity of the Commission for Social Development ab initio from 1994-1997. In Gregorian calendar month 1997, the Special recorder conferred his report on the results of his initial mandate to the 35th session of the Commission for Social Development and printed choices to additional implement the quality Rules. The Economic and Social Council set "to renew his mandate ...for an extra amount of 3 years (1997-2000)". In Gregorian calendar month 2000, Mr. Lindqvist rumored on the results of his second mandate to the ordinal session of the Commission for Social Development. The year 2000 session of the Economic and Social Council set to "renew (his) mandate....for an extra amount through the year 2002."

The question of elaborating a brand-new international instrument on the rights of persons with disabilities was mentioned within the report on the second mandate of the

Special recorder on incapacity of the Commission for Social Development. Following its thought of the item, the Commission counseled that the year 2000 session of the Economic and Social Council adopt a resolution on “Further promotion of feat of opportunities by, for and with persons with disabilities” that, inter alia, requests “the Special recorder, in consultation along with his panel of specialists, to ...present his views on additional developing the proposals contained in his report...and on forms for complementing and developing the quality Rules” and to submit a report back to the fortieth session of the Commission in 2002. The report of the Special recorder conjointly are going to be associate input to the fourth quinquennial review and appraisal on the implementation of the planet Program of Action regarding Disabled Persons which can examine the progress created and obstacles encountered in implementation of the Program of Action within the past 5 years still as for the amount of a decade once the international organization Decade of Disabled Persons (1983-1992).

B. New initiative for a world convention on the rights of persons with disabilities

President Vincente Fox of North American nation, throughout general dialogue of the fifty-sixth session of the overall Assembly (2001), known as upon the international community to combat financial condition and social exclusion; he explicit that societies ought to involve all voters as stakeholders which a simply world should be comprehensive of all teams. For that reason, North American nation had projected institution of a "Special Committee" to review the elaboration of a world convention on promoting the rights of persons with disabilities.

The UN General Assembly adopted the resolution 56/168, that established a commercial Hoc Committee to contemplate proposals for a comprehensive and integral international convention to market and shield the rights and dignity of persons with disabilities, supported the work worn out the sector of human rights and social development. The unintended committee can have its initial meeting from twenty nine July-9 August 2002 at UN headquarters.

As a part of the implementation of General Assembly resolution 56/168, The Meeting on the excellent and Integral International Convention to market and shield the Rights and Dignity of Persons with Disabilities (Mexico town, 11-14 Gregorian calendar month 2002) was organized by the govt. of North American nation, with the support of the UN Department of Economic and Social Affairs and therefore the sub-regional workplace in North American nation Economic Commission for geographic area and therefore the Caribbean (ECLAC).

C. problems associated with elaborating a special instrument on the rights of persons with disabilities

Experience would recommend that there are measure benefits and drawbacks to elaborating a brand new international instrument specifically addressing the human rights of persons with disabilities.

There square measure in depth lists of existing norms, principles, declarations, standards, and pointers addressing incapacity problems that square measure spread throughout numerous instruments. the prevailing human rights mechanisms at the international level haven't however absolutely addressed the rights of persons with disabilities inside their several mandates.

There is a read that a sufficiently specific, de jure binding instrument can be a far higher resource than this spread measures in this a brand new instrument might bring clarity to the present understanding of the rights of persons with disabilities and the way they work into the overall human rights framework.

A counter-argument to the elaboration of a brand new international instrument is that it might have the unintentional consequence of marginalizing the rights of persons with disabilities inside the UN human rights mechanisms still as within the general work of the UN within the field of incapacity. This unintentional consequence, plus resource constraints that already limit UN human rights mechanisms, might involve relevant issues.

Another issue is that the extent and therefore the extent of compliance by States to the international norms with reference to incapacity would play a big role in determinant however effective a world instrument are often for promoting the rights of persons with disabilities. whereas binding legal instruments have clear normative force, nonbinding instruments: declarations, resolutions, codes of conduct, pointers and choices of international bodies square measure gaining recognition as necessary sources of law.

The idea of norms has continuously been a dynamic one and therefore the standing of a selected instrument might amendment over time; Non-binding instruments result in the formation of binding agreements. Norms that square measure informal or restricted once negotiated might over time acquire legitimacy and normative force.

A number of specialists from the human rights community still as advocates for incapacity rights share the read that the problem of a brand-new international instrument ought to even be examined within the context of:

a) this constraints and potential for judgment of the human rights of persons with disabilities featured by the prevailing UN human rights mechanisms. These haven't however been absolutely explored either by legal specialists or advocates for the rights of persons with disabilities.

b) General issues of accessibility to the institutional resources for utilizing legal, body or alternative official procedures to adjudicate the rights of persons with disabilities.

c) The access and therefore the use of the domestic (national) judicatory and therefore the issue of underutilization of law within the domestic courts.

d) management of {the incapacity} community still because the community at massive - the problem of capability building within the disability community still as non-traditional sectors of society to handle problems with concern to them within the existing judicial and body fora and thru promoting general awareness and education to tell each the incapacity community and society as a full concerning the human rights of persons with disabilities as a crucial human offering.

e) Mainstreaming of incapacity in a very broader policy and legal discourse - networking among the incapacity community and their advocates, the supporting non-governmental community, tutorial establishments, legal specialists and practitioners to forge a way of integrated community to order the agenda for safeguarding and promoting the rights of persons with disabilities.

IV. Options for future action to promote the rights of persons with disabilities

As a result of consultation, interpretation and implementation of the vast existing body of international norms and standards concerning persons with disabilities, new networks and communities of disability-sensitized policy makers, program specialists, academics and advocates have emerged. Together, they are contributing to the universal application of the international norms and standards, which would thereby further the advancement of the rights of all. In considering plans for future action, the following points may be incorporated in recommendations to promote a society for all:

- Adoption of legislative frameworks by Governments that reflect international standards relating to disability that advance rights of persons with disabilities;
- Commitment by policy makers, program planners and technical experts to broaden policy dialogues with regards to the incorporation of international norms relating to disability as well as specific legislative mandates that emanate from the disability legislation in their respective countries;
- Involvement of civil society in a broad discourse on law and disability policies; how to incorporate international norms in domestic legislation and policies
- Organization of innovative forums in which legal and policy professionals, academics and civil society can exchange knowledge and experience as well as obtain technical guidance and advice on development of disability-sensitive policies and laws.

Human rights for persons with disabilities encompass human rights in all spheres of life. The future work of the disability community has the potential to integrate the resources of “traditional” human rights communities, focusing on political and civil rights and "non-traditional" human rights communities, focusing on economic, social and cultural rights, as well as civil society organizations that have not yet focused on issues concerning persons with disabilities. Together newly emerging disability-sensitized communities would work toward the goal of a society for all in promoting

economic, social and cultural rights from a disability perspective, which would play a significant role in the common endeavor of the international community to achieve a society accessible for all.

V. Conclusion

The issue of human rights of persons with disabilities will be further discussed within the frameworks of the fourth review and appraisal on the implementation of the World Program of Action concerning Disabled Persons in 2002 as well as in the report of the Special Rapporteur on Disability of the Commission for Social Development to the fortieth session of the Commission for Social Development in 2002.
